

## <u>Office of the Emperor of Adammia</u> <u>Decree LXXXII</u>

UPON OUR IMPERIAL MAJESTY'S SOVEREIGN COMMAND, NOTING that various territories of the Empire are no longer inhabited by its citizens, whilst new territories have been offered by citizens;

BE IT DECREED as follows:

The Provinces of Llanadda and Metchlia are hereby dissolved, and the counties, municipalities and all other territories constituting them are hereby ceded to the United Kingdom of Great Britain and Northern Ireland. Accordingly, the counties of North Astonia, South Astonia and Elgaria, and the municipalities of Astonville and Astonia Ulterior, are dissolved.

The bedroom of Lord James Green, as well as the gardens belonging to his residence, at his current residence in the County of Gloucester in England, shall be claimed as territory of the Empire, and shall constitute the Colony of New Astonia. Lord Green shall serve as Governor of this colony, in which capacity he shall hold the title of Count of New Astonia and the style of Lord, which shall be held by him and his descendants for all time to come until We the occupant of this Office decree otherwise.

The bedroom of Lord Patrick Gilbert at his current residence in the City of Sheffield in the West Riding of the County of York in England shall be claimed as territory of the Empire, and shall contitute the County of West Sheaffia, which shall be part of the Province of Sheaffia. The territory formerly comprising the totality of Sheaffia shall now be the County of East Sheaffia.

The colonies of Casa del Dank and New Astonia shall henceforth both be part of the Region of Outer Adammia.

Per Article VII Section 3 Subsection a) of the Supreme Directive, We hereby exercise Our unilateral right to issue titles to any citizen by declaring that Lady Emily Simpson shall continue to hold the title of Duchess of Llanadda and the style of Her Grace, and that Lord Charles Michael shall continue to hold the title of Duke of Metchlia and the style of His Grace, indefinitely, until We the occupant of this Office decree otherwise, and that they shall continue to be regarded as Adammic nobility of equal rank and standing in the order of precedence as they were prior to the signing of this decree.

We hereby declare that Lord Sam Maude shall be Count of Maternia, that Lord Patrick

Gilbert shall be Count of West Sheaffia, that Sir Kurtis Crossland shall be Count of East Sheaffia and shall hold in that capacity the style of Lord, that Lord Colonel Asher Bond shall be Count of East Corellia, and that Lord General Sir Alexander Read shall be Count of West Corellia. We also declare that Sir Joseph Norris shall hold the title of Lord Steward of Ashoria and shall hold in that capacity the style of Lord.

This, the eighty-second Imperial Decree of Our Imperial Majesty Emperor Adam the First, is decreed at Asquith House in Turing in the Colony of Lagentia, on this the twenty-fifth day of October of the two-thousand and twenty-second year of the Common Era, and is signed into immediate effect.
