## DECLARATION OF GENERAL ELECTION RESULT

The Office of State does hereby give notice that the results of the General Election of national members of the Ruling Council, held between Saturday the 26<sup>th</sup> and Sunday the 27<sup>th</sup> of November 2022, are as follows:

| That the number of valid ballots cast was   | - | 23 | (100.00%) |

And that, with 23 out of the 50 eligible electors having cast votes, the turnout for the election was 46.00%.

The quota for election at the first round was calculated as 5.75 (rounded to 6).

The total number of ballots allocated to each candidate at the first round was:

With no candidate having met the quota, the candidate with the fewest votes, Lord Sir Joseph Norris, is eliminated. Ballots allocated to him are redistributed according to next preferences.

The total number of ballots allocated to each candidate at the second round was:

Having met the quota, Lord Sir James Green is duly elected as a national councilor. With a surplus of 0 over the quota, ballots allocated to him shall be discarded.

With no candidate having met the quota, the candidate with the fewest votes is eliminated. By random lot this is determined to be Colonel Sir William McCracken. Ballots allocated to him are redistributed according to next preferences.

The total number of ballots allocated to each candidate at the third round was:

LLOYD, Alexander (Independent Party) - 4 (23.53%)
MICHAEL, His Grace Lord Sir Charles Richard (Liberal-Moderate Party) - 8 (47.06%)

Having met the quota, His Grace Lord Sir Charles Michael is duly elected as a national councilor. With a surplus of 2 over the quota, ballots allocated to him shall be redistributed with a weight of 0.25.

The quota for the fourth round is recalculated as 5.25 (rounded to 6).

The total number ballots allocated to each candidate at the fourth round is:

With no candidate having met the quota, the candidate with the fewest votes, Alexander Lloyd, is eliminated.

Sir Edward Patrick Hilton is therefore duly elected as a national councilor.

The Office of State does thereby declare that Lord Sir James Green, His Grace Lord Sir Charles Michael, and Sir Edward Hilton are duly elected as national members of the Ruling Council.
