IMPERIAL DECREE – Decree LXVIII (Imperial and Military Symbols) His Imperial Majesty the Emperor

#### Order.

I am pleased to lay before the House Imperial Decree LXVIII, issued on the 19th of December. This creates an Imperial Standard, which is the flag of the monarchy and the Emperor's personal flag. It also creates flags for each of the service branches of the military: a "war flag" for the Army, and ensigns for the Navy and the Air Force, as well as a civil ensign for merchant vessels and the like. I invite honourable members to comment, ask questions, or to move to overturn if they so wish.
